### Thermally conductive, controlled volatility RTV silicone

#### **DESCRIPTION**

- Two-part, gray, thermally conductive RTV silicone
- 100:0.2 Mix Ratio (Base: Curing Agent)
- Designed for enhanced performance in extreme low and high temperatures

Meets or exceeds the ASTM E 595 low outgas specifications outlined in NASA SP-R-0022A and European Space Agency PSS-014-702, with a TML of  $\leq$ 1% and CVCM of  $\leq$ 0.1%

#### INSTRUCTIONS FOR USE

#### **Mixing**

Thoroughly stir base prior to weighing for curing agent addition as the product separates. Mix 0.2% by weight curing agent to the base just prior to use.

Caution: Curing agent may cause skin irritation. In case of eye contact, irrigate with water immediately and get medical attention. (Standard curing agent is Dibutyl Tin Dilaurate.)

#### Vacuum Deaeration

Remove air entrapped during mixing by common vacuum deaeration procedure, observing all safety precautions. Slowly apply full vacuum to a container rated for use and at least four times the volume of material being deaerated. Hold vacuum until bulk deaeration is complete.

#### Adjustable Cure Schedule

Product cures at a wide range of cure times and temperatures to accommodate different production needs. Contact NuSil Technology for details.

#### **OPERATING TEMPERATURE**

The operating temperature range of a silicone in any application is dependent on many variables, including but not limited to: temperature, time of exposure, type of atmosphere, exposure of the material's surface to the atmosphere, and mechanical stress.
